The history of the SIG Combibloc beverage carton is only a few years younger, and dates back to the invention of 'Perga,' Europe's first beverage carton. In 1989, ownership of the German packaging company is transferred to SIG Holding AG in Neuhausen am Rheinfall, and in 1998 the company is rebranded to SIG Combibloc. In 2007, SIG was taken over by the Rank Group, New Zealand. Since 2015, SIG has been part of the Canadian-based private equity company Onex Corporation.
